PGET-2025 Second Mop-Up Round Certificate verification Cum Counselling for admission into MPO course for PDUNIPPD will be held offline mode on 15.09.2025 to fill up the vacant seats remaining after 1<sup>st</sup>, 2<sup>nd</sup> & First Mop-up rounds of admission and cancellation of admission thereafter, details are given below. Additional vacant seats will also be filled up if any vacancy arises on cancellation of admission after this notification on or before the 2<sup>nd</sup> Mop-Up Round admission. #### **Eligibility to attend Second Mop-up round:**

Following category candidates are permitted to attend PGET-2025, Mop-Up Round Certificate verification cum Admission.

1. All candidates who have appeared the PGET- 2025 and a rank holder of the Entrance Examination irrespective of their rank are eligible to attend Mop-up round. However there is no guarantee of admission. Admission will be made on the basis of merit keeping in view of the category.

- 2. Candidates who have allotted seat during earlier rounds and paid the part admission fee of Rs. 10,000.00, verified documents in the reporting Institutes but not paid rest amount of admission fee are eligible as per their Rank.
- 3. Candidates who have allotted seat during earlier rounds and paid the part admission fee of Rs. 10,000.00 but not verified documents in any of the rounds are eligible as per their Rank.
- 4. Candidates who have allotted seat during earlier rounds but not paid the part admission fee of Rs. 10,000.00 are eligible as per their Rank.
- 5. Any other candidates who have not allotted any seat during earlier rounds are also eligible to attend.
- 6. Seats under ST category will be converted & interchangeable to SC category & vice versa subject to non-availability of such category candidates.
- 7. The selection & call for counselling of the candidate is provisional & does not guarantee for admission. If any false information or discrepancy is observed at any stage of admission or the period of study, his/her candidature shall stand cancelled.
- 8. The candidates will be offered the seat and Institute available/vacant at his/her turn as per rank.
- 9. The candidates interested to participate in Second Mop up round should be present physically with all required documents on stipulated date & time without fail at the Reporting Centre Address as mentioned.
- 10. A candidate, who fails to appear in person due to any reason (Including medical) on the notified date and time for counselling shall forfeit his/her claim for admission even against a vacancy, which may arise in future. No representation on this account will be entertained.
- 11. Immediately on arrival, the candidate shall mark his/her attendance for the counselling (from 09:00 AM to 11:00AM) on the stipulated date.
- 12. On Completion of the attendance within the above time, an ascending order of the candidates given their attendance will be published on the basis of their Common rank.
- 13. The reported candidates will be called to the admission desk one after another from the prepared ascending order merit list. They are advised to keep themselves ready with all the required documents before proceed to the admission table.
- 14. Admitted candidates are not allowed to attend the Mo-up round.
- 15. The procedure of counselling to be followed as mentioned in INFORMATION BROCHURE FOR POST GRADUATE ENTRANCE TEST (PGET-2025).
